Housing at Mungabareena Aboriginal Corporation

Mungabareena Aboriginal Corporation has a limited number of properties which are considered as subsidised social housing.

Applications are placed onto the Housing List and are prioritised from time to time as and when required, through a formal allocation process as per the Housing Allocations Policy.

All allocations are confirmed by the Board of Directors.

This application does not guarantee you immediate housing, and the waiting list is quite extensive. Applicants should always maintain regular contact with the Administration Office of Mungabareena Aboriginal Corporation, to ensure details are current and accurate.

Am I eligible for housing with Mungabareena?

To be eligible for Mungabareena housing you must meet the following basic criteria requirements

- Applicant must be aged 18 years or older.
- Applicant must be an Aboriginal and/or Torres Strait Islander person or;
- A member of an Aboriginal and/or Torres Strait Islander household.
- Applicant must be a member of Mungabareena Aboriginal Corporation for a minimum period of 3 months.
- Applicant must be an Australian citizen or permanently residing in Australia.

Community members who have the capacity to obtain housing privately, or through a real estate are encouraged to refrain from applying with Mungabareena.

What if I'm ineligible?

If for whatever reason Mungabareena is unable to provide you with housing, you will be referred to another agency/service.

Required Documentation

Before submitting this application, we ask that you ensure you have completed all sections and have the following documentation attached:

- A completed Identification Check form for all occupants signed and sighted by a staff member.
- Most recent 3 bank statements.
- Most recent 6 pay slips (if employed).
- Recent Centrelink income statement for all applicable household members.
- Rental receipts of payment for a minimum timeframe of the previous two months.
- Confirmation of Aboriginality for at least one permanent household member;
